COMPATIBILITY/INTENDED USE

The L-Bracket Light Mount can be mounted to threaded eyelets on a frame or racks where the L-Bracket Light Mount will not interfere with any moving parts on the bicycle or the wheels, or affect handling.

TOOLS REQUIRED

4mm hex wrench
 Torque wrench that measures in Nm

INSTALLATION:

Mount the L-Bracket Light Mount to a threaded eyelet on your bicycle frame or rack and tighten the M5 bolt to 6Nm.

ONGOING MAINTENANCE

Periodically check to make sure the attachment bolts are tight.
